TASFAA Tribute

A Tribute to Herb Brubaker (Our Friend and Colleague)

Collected and delivered to membership at conference luncheon by Kim Alexander, TGSLC

I am honored to have been asked to provide a special tribute message to the TASFAA membership at this conference for one of our very special members whom we lost just a few months ago. Herbert Allen Brubaker passed away on August 2, 2013. We lost Herb on his birthday and far too soon at such a young age of 59. Herb received his undergraduate degree from the University of Mary Hardin-Baylor and received his Master's in Public Administration from Texas State University. Not only did Herb attend college in Texas, but he also worked tirelessly in student financial aid and with student loan programs for over 35 years. For over 30 years, Herb served in leadership roles for TASFAA, AASFAA, SWASFAA and NASFAA. Before he passed, he served as Campus Director of ITT Technical Institute in Little Rock, Arkansas. Herb was survived by his wife Jackie, 4 children, 3 sisters and 2 grandchildren.

I had the pleasure of knowing Herb personally as did many others here. In fact, I stepped into a position at TG that Herb vacated in 1991. You could say Herb was responsible for me stepping into it in more ways than one. There are many hilarious stories that those of us who were somewhat close to Herb could tell, but in the middle of all the stories was the fact that Herb cared deeply about the students he helped, the people he worked with, his family and TASFAA. Herb was very active in our association and helped establish leadership, structure and direction for TASFAA in the mid eighties. Herb was fun to be around and never met a stranger. I remember thinking after meeting him in the late eighties that this guy will say anything, do anything and find fun in everything. Herb was also a life-long learner although he would try to convince you that he knew everything. Later in life, Herb was a devoted member of the First United Methodist Church of Jonesboro where he taught bible and discipleship classes. Yes, our Herb!! He also organized and coordinated an annual fundraiser for Wayland Springs Church Camp. We are all truly blessed to have had Herb in our lives and TASFAA and the hundreds of members we have, have all benefited from his early vision and leadership for a professional organization whose mission is to help student aid administrators help students and families.

There are many people who knew Herb far better than I did who also kept in contact with him as he made his mark in Arkansas. Please indulge me for a few minutes as I read messages from a few of them:

"I am honored to have known Herb for thirty years. Herb was many things to many people, husband, father, pastor, colleague, counselor and Friend. I knew Herb when he was TASFAA President, worked at TG then Brazos, then on to Arkansas at lenders and most recently at ITT. Fortunately, my work and travels allowed me to continue to see him and his wife Jackie there as well as at NASFAA on occasion. Herb touched and stayed in touch with so many people, literally I really am not sure how he did this was it calculated or random? Yet he rarely let you slip far from his radar screen. The magnitude of his staying in touch was discovered more so after his passing among those of us sharing the last time we chatted and how often we all spoke with him. Herb made sure not more than a month or two went by and he would call and say, 'how's it going? What's new in your life, really how are you?' He genuinely cared for his friends and financial aid colleagues. Many times we would reminisce about the good old days and share many laughs. Herb was also great about sharing emails, jokes and quips to brighten a day. He was also a golfer, in Texas and Arkansas many golfers shared time with Herb. Best of all he took the time to listen and in the days of Lender hotel receptions, Herb would always invite other lenders to join in and said it's about community and the financial aid community sharing time together...he was truly gracious! He was devoted to his family, work, friends and the Lord. While I miss him dearly and his random phone calls, I am blessed to have called him my friend. When I think of Herb, I think of a very familiar Aesop quote: 'No act of kindness, no matter how small, is ever wasted.' This was the core character of Herb Brubaker."

"As we all were saddened to learn of Herb's passing, I could not help but think of how truly blessed I was to have known and worked with him at TG. He was an outstanding student aid administrator and leader of TASFAA and was admired and respected by many. Having Herb on the staff at TG was truly an asset; he was a most dedicated and outstanding employee who contributed greatly to TG's success in those early years. The thing I admired most about Herb was that he truly cared and was dedicated to the students and financial aid colleagues we were trying to serve. On a lighter note, Herb was also a very courageous man in that he was one of the few TG staff brave enough to ride with me on our numerous road trips together. We will all miss Herb very much and I wish God's blessings on his family."

"I hired Herb in 1984, when he was President-Elect of TASFAA. Herb was not from a golden spoon background himself, and he had huge empathy for students who had the desire but not the financial ability to attend college. He was an exceptional counselor - almost to a fault. He would accept any story a student told him, sometimes without evaluating the legitimacy of the story. Herb worked on several sides of the financial aid world, but I never felt like he was looking for the next job. The next job always seemed to come looking for him - because of his vast network of colleagues. Herb kept up with people - he always kept up with me. He would call me in the last few years as he was driving back and forth between his home in Jonesboro and work in Little Rock and we'd catch up."

Herb never tried to be sophisticated or overly affluent, so instead of a formal toast to his leadership and work in our industry, please join me in a big high five and a "well done Herb!!"

In the spring, the committee invited everyone to apply for the Mack C. Adams Professional Development Scholarship. The scholarship was made available for the New Aid Officers Workshop held in May and 10 applicants received \$200 toward their expenses associated with attending the NAOW. This scholarship was designed to assist financial aid professionals with the cost of attending TASFAA-sponsored training opportunities. Along with financial assistance, recipients also receive an opportunity to grow as a financial aid professional and make important connections with others in their field. Applications for the Mack C. Adams Professional Development Scholarships were not made available for the TASFAA fall conference due to budget constraints.

Nominations for the TASFAA Financial Aid Star, Trailblazer, and Hall of Fame awards were solicited at the end of May. Only 4 nominations were received for the Financial Aid Start award and no nominations were received for the Trailblazer or Hall of Fame awards. Palyce Williams of Texas A&M University in College Station was selected as the TASFAA Financial Aid Star winner and was presented her award at the fall conference in Galveston, TX. The special guest included Justin Draeger, NASFAA President and Lisa Hopper, SWASFAA President. Our Keynote speaker was nonverbal Communications expert Jan Hargrave. Special Thank you to TG for continuing to support our financial aid community efforts, by picking up the slack and presenting 4 sessions in the place of our Department of Education trainers.

Our breakout sessions included many topics of discussion, along with our general sessions that included the Federal update, the State update, and a session on campus security.

We raised \$2250.00 through the 5K run/walk race and the raffle for the Mack Adams scholarship fund. On Thursday evening we had our first Mardi Gras ball of the Krewe of Chaos and it was fabulous. We also had a great band from Galveston and a photo booth to entertain us at the ball. As always our exhibitors supported us with great displays and booths.

Legislative Issues Committee

The Legislative Issues Committee worked to promote the Association's position on, as well as better inform the discussion about, proposed legislation affecting financial aid programs. For example, the committee developed and distributed to legislators and others a TASFAA position paper entitled, Ensuring Student Success and Access - Spring 2013. This paper, based on survey data from the TASFAA membership, addressed proposed legislative changes and made recommendations to promote effective state financial aid programs that best serve Texas and its students.

In addition, the committee collaborated with TG to craft and submit a letter to Congressman Joaquin Castro, as well as other members of the U. S. House of Representatives, regarding TASFAA's support of HR 1529. The bill proposes to amend Title IV of the Higher Education Act of 1965 to exempt interest-free, forgivable private education loans that are originated by a state (such as the B-On-Time Loan) from rules and regulations applicable to preferred lender arrangements.

During the Texas legislative session, committee members monitored bills having a direct or indirect impact on financial aid programs and recipients. A number of alerts were sent out to the TASFAA membership informing them of new high-impact legislation as it was introduced. The committee members also acted as a legislative resource for schools wanting to learn more about proposed legislation and its potential effect on their operations.

In the coming year, the committee will continue soliciting input from TASFAA members in crafting the Association's position on relevant legislative and policy issues. In addition, members will focus on strengthening TASFAA's role in influencing the design of state financial aid programs and policies that more effectively assist students in reaching their higher education goals.



Membership Committee

TG's PRAF team Michelle Anderson and David Garza continue to do an exceptional job presenting on Federal Updates and have become great resources when questions arise from the audience requiring immediate research.

TG's Regional Site Coordinators continue to be great liaison's to the FAA community at the various Texas sites.

Show What You Know:

Together TASFAA, THECB, and TG developed a "Show What You Know" session that tested our participant's knowledge on the topics covered. This year certificates were provided to those who scored 1st, 2nd, and 3rd place. Ties were common and occurred at each location; both participants would walk away with a certificate signed by each representative. This echoed to our training team that our participants were engaged and ready to deliver what they learned in the all-day training session.

Evaluation Scores:

The information below provides an overview of the seven sites we conducted this year's 2012-2013 Texas Regional Training. The evaluation scores are on a scale from 1-5 and we received high marks from each location. We reached a total of **421** FAA attendees which includes an increase of 67 from 11-12.

Challenges:

Chair and Co-Chair discussed a challenge that TASFAA Regional continues to face which includes the time constraint on the preparation for the NASFAA Fall Training material. Although the material is well put together with Instructor's and Participants Handouts, it can quickly become outdated, over simplified, or irrelevant to the majority of participants. It is critical for the members of the Regional Training Committee to come up with alternative (back-up) presentations to plug into the Texas Regional

Training and not be reliant on the NASFAA Fall material. Since our first training is typically the first week of December awaiting the NASFAA fall material can be daunting for the following reasons:

- Agenda cannot be set until NASFAA material received
- Presenters have less than 3 weeks to learn the material and set an outline on how material should be presented
- Time restrictions to create a Hands-On activity affiliated with presentation
- 3 hour time block required according to NASFAA for presentation however often has to be adjusted
- Presentations, Materials used printable handouts must be submitted to TG by Nov. deadline typically a busy time for Committee members attending State, Regional and FSA conferences
- Topic is novice- Part 1 of Direct Loans included basic understanding of Loans (i.e. MPN, Entrance Counseling etc..)
- Topic is too advanced or not relative to participants -(i.e. Reconciliation)
- Topic was not researched accurately, TG's PRAF team found multiple errors with NASFAA's CDR slides that required clarification

Solutions:

- TASFAA Regional Training Committee member sit in on NASFAA's Fall training committee to work on upcoming material
- Regional Training Chairs should be provided the material as soon as it is available in order to prevent delay in preparation
- Use NASFAA training material, if noted novice/advance create break out rooms for participants to choose to attend. This is really easy as we typically split the presentation in two Morning/Afternoon and the time before and after lunch is typically blocked by TASFAA
- Have participants fill out NASFAA evaluation (Regional Training Chair should collect and submit to NASFAA once all sites are completed including
- TASFAA Regional Training conduct all training in the spring January/February in a two week period—spring is an extremely busy time in FA offices, and weather may not permit travel
- TASFAA Regional committee can build their own presentations regarding FA Hot Topics
 - Send a survey to TASFAA list serve to find out what is needed
 - Review participant evaluations
 - Review FSA topics
 - FA Chat Chat discussion with Financial Aid Administrators nation wide
 - Collaborate with SWASFAA Regional Training Committee Chair/Members

Updates & Changes:

Updates have been made to TASFAA Regional Training Committee Purpose, Responsibilities and Monthly Calendar including TASFAA Regional Training Leadership Information.

Delisa Falks, will step in as new chair for 2013-2014. Since regional training ends in March the planning for the new year begins in June requiring the agenda and presentations to be decided by October. It is a quick turnaround and would be ideal for co-chair to continue to be appointed so that the chair can experience a smooth transition.

Going Forward:

TG and THECB both have reliable resources that both agencies are willing to extend for a successful recorded training (either in webinar format, or live audience). This may be a possibility for future chairs/members to explore. The pros of having a recorded training would allow our team to share our training information to an even larger FAA audience. In addition it would help us to recognize the FAA communities that are unable to reach our site destinations and assess the reason. Our team shares the concern that we would not want the recorded training to be a first choice for our participants. We continue to believe there is significant value for a live training that fills the need of our FAA community. The recorded training would be presented after the site dates have concluded for those who were unable to attend. Unfortunately due to timing constraints our desire to include our first recorded training was not feasible.

We may also explore connecting and collaborating with our fellow SWASFAA Regional Training committee to see how Regional Training can evolve even further.

The TASFAA Regional Training Committee will continue to present on the most critical topics essential to understanding changes that affect our FAA community.



Site Selection Committee

The fall 2013 TASFAA Conference "Charting the Course of Financial Aid" was held at the beautiful Hilton Island Galveston Resort from Oct. 7-11. Returning to Galveston this year was a financially sound decision that enabled TASFAA to take care of some prior room attrition issues from the fall 2010 conference that was also held in Galveston. On October 9th- 10th the Training Committee welcomed about 35 participants to the 2012 ABC Workshop. The ABC Workshop takes place a day and a half before the Annual TASFAA Conference.
